This award is granted to ONE ASSOCIATE and ONE REGULAR MEMBER of the RMFMA who has contributed time and effort in the promotion and operation of the Association. Such distinguished contributions should consist of serving on special committees, doing research, writing reports, obtaining new members, assisting with meetings, community service, serving as officers and promoting the goals and objectives of the Association.

Recognition

The Outstanding Service Award recipients will receive recognition for their contributions during the RMFMA Annual Meeting this year.

To Submit A Nominee

Please complete the information on page 2 of this form and describe the achievements of the nominee. Be specific and include as much detail as possible. The more supporting information received, the better the candidate can be evaluated. Use extra paper to support the information areas on the form. Include examples, letters, and other documents. You may nominate a member within your agency, from another agency, or you may nominate yourself. Nominations can come from all levels and job descriptions within the area of Fleet Management.

Judging

The awards committee consists of the President-Elect, and Vice-Chair from each Chapter. The committee will select the two recipients (one Regular member and one Associate member) from the entry forms by giving an opinion of who is most deserving. In cases where a unanimous decision cannot be reached, a secret ballot will be conducted.

Rules

Any Regular Member or Associate Member in good standing can be nominated including oneself. **THE RESULTS OF THE AWARD WILL BE KEPT CONFIDENTIAL AND WILL NOT BE ANNOUNCED UNTIL THE AWARDS CEREMONY AT THE ANNUAL CONFERENCE.**
